I, Ashish Kumar Gaggar, Company Secretary in Practice was appointed as Scrutinizer by the Board of Directors of the Company for the purpose of the Postal Ballot carried out by the company as per the section 110 of the companies Act, 2013 and Rule 22 of the Companies (Management and Administration) Rules, 2014 on the resolution as mentioned in the notice of the Postal Ballot dated 09 November 2015 submit my report as under:-

1. The dispatch of Notice of the postal ballot dated 09 November 2015, was completed on 12th January, 2016
2. The company has also engaged the services of the CDSL the authorized agency to provide the remote e- voting facility to the shareholders.
3. The e-voting Period commenced on Friday, 15 January, 2016 (9.00 a.m.) and ended on Saturday, 13 February, 2016. (5.00 p.m.)
4. The shareholders holding the shares as on the "Cut off" date i.e. Friday, 01 January, 2016 were entitled to vote on the proposed resolution.
5. As per the requirements of Companies Act, 2013 the particulars of all the postal ballot forms received (through physical and electronic mode) from the members have been registered in a register maintained separately for the purpose.
6. The ballot forms were kept under my safe custody in sealed and tamper proof ballot envelopes before commencing the scrutiny of such postal ballot forms.
7. All postal ballot forms received up to 5.00 p.m. (IST) on 13 February 2016, being the last date and time fixed by the company for receipt of the forms were considered for my scrutiny. Envelopes received after this date were not considered.
